## **NOTICE OF INTENTION TO DESIGNATE ONTARIO HERITAGE ACT 33 ROOSEVELT AVENUE, AJAX**

TAKE NOTICE that the Council of the Corporation of the Town of Ajax intends to designate the property known as 33 Roosevelt Avenue, legal description Plan 510, Lot 11, in the Town of Ajax, as a property of architectural and historical value or interest under Part IV of *The Ontario Heritage Act* (R.S.O 1990, Ch. O. 18). A By-law to designate the property is scheduled to be before Ajax Town Council at its regular meeting to be held June 8, 2009.

### Reasons for Designation:

This is a 1½ storey apartment building, located at the southeast corner of Roosevelt Avenue and Kings Crescent in the central core of Ajax. It forms an integral part of a grouping of eight buildings owned by Canada Mortgage and Housing Corporation (CMHC) which were constructed during World War II to house the managers and supervisors of Defence Industries Limited.

This building's cultural heritage value results from its historical significance, specifically its close association with the origins of Ajax and the establishment of the DIL plant. Architecturally, it is one of three uniquely-designed apartment buildings in the town.

The key attributes exhibited by this building include:

- The harmonious fit between the five buildings constructed to house the managers and supervisors of the DIL plant in the vicinity of Kings Crescent, Churchill Avenue and Roosevelt Avenue which form a unique cluster of 1940's architecture;
- Its attractive, low-rise façade, highlighted by a row of six dormers set into the roofline;
- Its contribution to the streetscape of Roosevelt Avenue

Additional information on the proposed designation is available at the Legislative and Information Services Department.

Any person may send by registered mail or deliver to the Clerk of the Town of Ajax notice of their objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Town of Ajax will refer the matter to the Conservation Review Board for a hearing.

THE LAST DAY FOR FILING OBJECTIONS IS MAY 30, 2009
