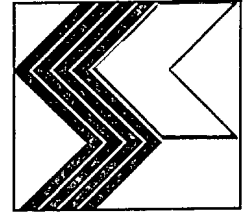

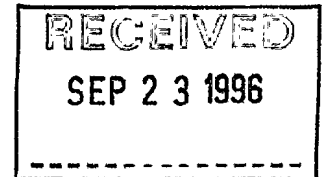

BY-LAW NO. 96-262

CERTIFIED under the Hand of the Clerk and the Seal of the CORPORATION OF THE CITY OF ST. CATHARINES to be a TRUE COPY of By-law 96-262 of the Corporation of the City of St. Catharines

A By-law to repeal By-law No. 90-395 entitled "A By-law to designate the property at 24 Yates Street to be of historic or architectural value or interest".

WHEREAS the property hereinafter described was designated by the Council of The Corporation of the City of St. Catharines under Part IV of the Ontario Heritage Act, R.S.O. 1990, c. 0.18 by By-law No. 90-395;

AND WHEREAS it is proposed to designate as a heritage conservation district under Part V of the Ontario Heritage Act an area which includes the property hereinafter described;

AND WHEREAS the Ontario Heritage Act provides that no property designated by a council of a municipality under Part IV of the Act shall be designated as a part of a heritage conservation district under Part V thereof.

AND WHEREAS in repealing the By-law designating the property at 24 Yates Street The Corporation of the City of St. Catharines through inadvertence enacted By-law No. 95-298 to repeal By-law No. 78-357, which formerly designated the property, instead of By-law No. 90-395 whereby the property is currently designated under Part IV of the Act.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF ST. CATHARINES enacts as follows:

1. That By-law No. 90-395 relating to the property described in Schedule "A" hereto be and the same is hereby repealed.
2. The City Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.

3. The City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of the By-law to be published in a newspaper having general circulation in the City of St. Catharines.

4. That By-law No. 95-298 be and the same is hereby repealed.
