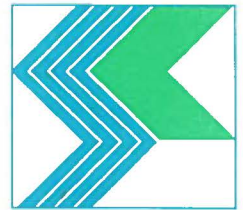


BY-LAW NO. 2015-206

A By-law to amend By-law No. 86-53 entitled "A By-law to designate the property at 160-168 St. Paul Street of architectural value and of historic interest."


THE COUNCIL OF THE CORPORATION OF THE CITY OF ST. CATHARINES enacts as follows:
