



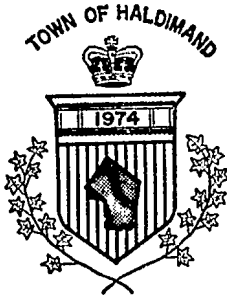

TAKE NOTICE that the Council of the Corporation of the Town of Haldimand intends to designate the property, including lands and buildings, at the following municipal address as a property of historical value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

- (a) The Old Caledonia Mill, Part Lot 13, Oneida Plan 331, RP 18R1671 Part 2, 146 Forfar Street in the Town of Haldimand in the Regional Municipality of Haldimand Norfolk, in the Province of Ontario, formerly the Town of Caledonia.

Reasons for Proposed Designation

- (1) Began to process wheat into flour in January 1857.
- (2) Last mill to be in operation along the Grand River using water power.
- (3) A surviving link with the Grand River Navigation Co. of the past.
- (4) A memento to many enterprising men of Caledonia and area:
James Little, J.B. Holden, John Scott, Donald McQuarrie
1832 - 1887, William Munro 1825 - 1901, James H. Thorburn
1845 - 1903, Samuel Scott, William Scott, Hugh Scott, Ob Scott.
- (5) Great old landmark.
- (6) One of the last mills left of this type of structure.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Haldimand before the twenty-eighth day of October, 1983.
