THE CORPORATION OF HALDIMAND COUNTY

By-law No. 732/06

Being a by-law to designate certain attributes on the property, known as the Mooney Residence, situated in the former Town of Dunnville as being of a cultural heritage value or interest.

WHEREAS Sections 29 of <u>The Ontario Heritage Act</u>, R.S.O. 1990, Chapter 0.18, authorize the council of a municipality to enact by-laws to designate property, including certain attributes of the real property thereon, to be of cultural heritage value or interest;

WHEREAS the Council of The Corporation of Haldimand County has caused notice of intention to be served on The Ontario Heritage Foundation and upon the owners of the lands and premises known municipally as 210 Broad Street West, in the former Town of Dunnville, to be designated property including real property thereon as being of cultural heritage value or interest;

WHEREAS the Council of The Corporation of Haldimand County has caused such notice of intention to be published in a newspaper having general circulation in the municipality for one week;

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of Haldimand County within the time prescribed by the said statue;

AND WHEREAS the reasons for designation are set out in a Schedule "A" attached hereto;

NOW THEREFORE, the Council of the Corporation of Haldimand County enacts as follows:

- 1. THAT the property located at or within the premises known as the Mooney Residence at 210 Broad Street West, in the former Town of Dunnville, is hereby designated to be of a cultural heritage value of interest for reasons set out in Schedule "A", attached hereto and forming part of this by-law;
- 2. THAT a copy of this by-law will be registered in the land registry office against the property located at 210 Broad Street West, in the former Town of Dunnville, now in Haldimand County more particularly described in Schedule "B" attached hereto and forming part of this by-law.
- 3. **AND THAT** the Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on The Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the municipality for one week.

READ a first and second time this 8th day of August, 2006.

READ a third time and finally passed this 8th day of August, 2006.

Schedule "A" to By-Law No. 732/06

Reasons For Designation

The house at 210 Broad Street West in Dunnville, owned by the Bartlett Family for many years, is a fine example of the homes built by the successful merchants of the town at the turn of the 20th century. It has many decorative architectural features, such as herringbone hardwood flooring, ornate brickwork fireplaces, elaborately cast furnace grates, large arched top doors and multi paned windows. A special feature of the home is the 1930's kitchen with cabinetry and style typical of the period, and very well preserved.

This residence is one of many historic properties located along Broad Street in Dunnville, worthy of preservation for future generations.

Items For Designation

- 1. All ornamental soffit corbels.
- 2. 1930's kitchen/pantry.
- 3. All arch top wooden doors.
- 4. All ornamental cast iron grates.
- 5. All brick fireplaces.
- 6. Front porch.
- 7. Side porch.
