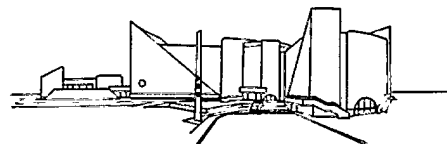

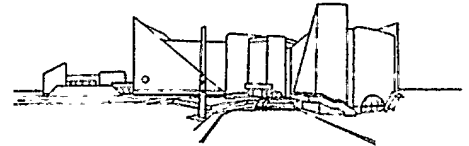

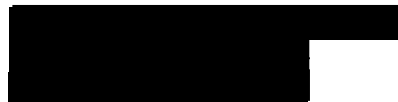

Take notice that the Council of the Corporation of the
Borough of Scarborough has decided to designate the lands and
buildings, known municipally as 15 Port Union Road, as a
property of architectural value or interest under The Ontario
Heritage Act, 1974, S.O., Chapter 122.

Short Statement of the Reasons for the Proposed Designation:

"Laskey Hotel". This building is the last nineteenth
century hotel structure left in Scarborough. Built in the typical
hotel style of that era, the building is a duplicate of a
Helliwell's Hotel which was destroyed by fire and of the
Halfway House relocated at Pioneer Village. Architecturally the
building is a good example of an early nineteenth century Upper
Canadian vernacular hotel structure, featuring two storey
dimensions with medium pitched gable roof and a symmetrical
five bay south front facade with two-storey veranda.

Notice of objection to the designation may be served
on the Clerk within thirty days of April 5, 1978.
