

THE CORPORATION OF THE CITY OF WOODSTOCK

By-law Number 6557-88

A by-law to amend By-law Number 5245-76 of The Corporation of the City of Woodstock.

WHEREAS By-law Number 5245-76 designated the property municipally known as 479 Wellington Street North of historical value.

AND WHEREAS the owner of the property has requested and applied to the Council of the municipality to repeal part of By-law 5245-76.

AND WHEREAS the Council has sought and received consultation from its local Advisory Committee.

AND WHEREAS the Council has consented to pass a by-law repealing part of By-law 5245-76.

NOW THEREFORE, the Council of The Corporation of the City of Woodstock enacts as follows:

1. That By-law 5245-76 registered as Instrument Number 234102 is hereby repealed as far as it relates to Blocks 19, 20, 21, Jack Poole Drive, Hutchinson Drive, Lots 1 to 7 inclusive and Lots 9 to 18 inclusive all according to Plan 41M-102.
