NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the City of Windsor intends to designate the property, including lands and buildings at the following municipal address as a property of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act:

3305 Sandwich Street at Brock (Part 40, Lot 9)

REASONS FOR DESIGNATION:

Historical:

- The Saint John's Church parish can trace its history back to the beginnings of English Canada.
- From 1796, the first Anglican minister of Sandwich, Richard Pollard, held meetings in a
 log civic building until the first St. John Anglican Church was built c1803-1806. The
 retreating Americans burned this church to the ground during the War of 1812.
- In 1819 a new church was built, added onto in 1843 and a tower constructed in 1852. In 1871, the rear portion of the building was torn down and rebuilt. The church was again expanded in 1957.
- The adjacent cemetery is the oldest Anglican graveyard west of Niagara Falls, with stones dating from 1793.

Architectural:

- The basic form of the red brick and limestone church is a basilica with apse and transept, "cathedral" ceiling, main entry through tower narthex. The tower is Norman style, while the main church is Gothic.
- Tombstones in the cemetery range from historic markers of local limestone to modern monuments of granite or marble.

Any person may, within thirty days of the publication of this notice, send by registered mail or deliver to the Clerk of the City of Windsor notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Windsor shall refer the matter to the Conservation Review Board for a hearing.
