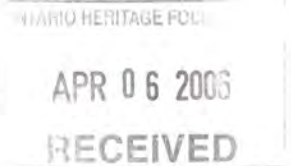

TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-015

Being a By-law to designate 201 Smith Street
in the former Village of Elora,
to be of Cultural Heritage Value or Interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural Heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

1. The lands and premises described as 201 Smith Street, Plan 112, Lot 36, E/S Smith St., Part Lot 37, W/S Geddes Street, (Formerly Village of Elora), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
2. The reasons for the designation are as follows:

Cultural Heritage Value or Interest:


This 1873 Ontario Cottage style, 1 ½ storey single detached dwelling features a rectangular long façade, stone walls with tape pointing, a centre gable, sash windows 6/6 and chimneys on both right and left side.


Heritage Attributes to be protected:

Exterior stone walls with tape pointing.
Centre gable with original semi elliptical window.
Double chimneys, left and right side.
6/6 original windows with voussoirs and masonry trim.
Centre door with sidelights.


3. This By-law shall be registered against the title of the lands described as 201 Smith Street, Plan 112, Lot 36, E/S Smith St., Part Lot 37, W/S Geddes Street, (Formerly Village of Elora), now in Township of Centre Wellington
4. This By-law shall come into force and take effect upon its final passing.


