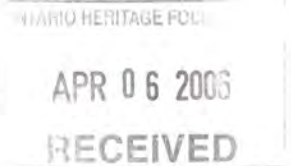

TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-012

Being a By-law to designate 193 Princess Street  
in the former Village of Elora,  
to be of Cultural Heritage Value or Interest

**WHEREAS** on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

**AND WHEREAS** the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:**

1. The lands and premises described as 193 Princess Street, Plan 181, Lot 100, E/S Princess St., (Formerly Village of Elora), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
2. The reasons for the designation are as follows:

**Cultural Heritage Value or Interest:**


This one storey single detached dwelling was built in 1868 by William Crackle, a bricklayer, who owned and lived in the house. The house features a rectangular long façade, stretcher brick, low hip roof, centre façade main entrance, two original front sash windows 2/2, and door.


**Heritage Attributes to be protected:**

Red stretcher handmade brick covered in board and batten.  
Main entrance centre façade.  
Two front original sash windows 2/2.


3. This By-law shall be registered against the title of the lands described as 193 Princess Street, Plan 181, Lot 100, E/S Princess St., (Formerly Village of Elora), now in Township of Centre Wellington
4. This By-law shall come into force and take effect upon its final passing.


