TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-018

Being a By-law to designate 245 Union Street West in the former Town of Fergus, to be of cultural heritage value or interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as 245 Union Street West, Plan 77, Lot 11, Part Lot 12, (Formerly Town of Fergus), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
- 2. The reasons for the designation are as follows:

Cultural Heritage Value or Interest:

This one-storey detached dwelling was constructed around 1855 and likely has a connection to the Gow limestone quarry, which was nearby. It is constructed of cut limestone in broken courses with large limestone quoins. Although renovations were completed in 2003 which included replacement of earlier 2/2 double-hung windows with 6/6 windows and a renovation of the entrance, the original limestone voussoirs have been retained.

Heritage Attributes to be protected:

The front façade of the dwelling including the quoins and voussoirs.

- This By-law shall be registered against the title of the lands described as 245
 Union Street West, Plan 77, Lot 11, Part Lot 12, (Formerly Town of Fergus),
 now in Township of Centre Wellington
- 4. This By-law shall come into force and take effect upon its final passing.
