TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-010

Being a By-law to designate 275 Geddes Street in the former Township of Nichol (Salem), to be of Cultural Heritage Value or Interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as 275 Geddes Street, Nichol Plan 112, Lot 1, E/S Geddes, Lot 1, W/S Erb, Salem, (Formerly Township of Nichol), now in Township of Centre Wellington are hereby designated to be lands and buildings of cultural heritage value or interest.
- 2. The reasons for the designation are as follows:

Cultural Heritage Value or Interest:

Built circa 1868 by stone mason Mr. Sutherland, this one storey single detached house features exterior walls of rubble stone with taped joints, field stone voussoirs over symmetrical 6/6 sash windows, a rectangular plan long façade with enclosed veranda, a main entrance centre façade, and a low gable roof.

Heritage Attributes to be protected:

All exterior rubble stone walls and 6/6 sash windows with field stone voussoirs.

- This By-law shall be registered against the title of the lands described as 275
 Geddes Street, Nichol Plan 112, Lot 1, E/S Geddes, Lot 1, W/S Erb, Salem,
 (Formerly Township of Nichol), now in Township of Centre Wellington
- 4. This By-law shall come into force and take effect upon its final passing.
