TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-30

Being a By-law to designate 6666 Second Line in the former Township of West Garafraxa, to be of Cultural Heritage Value or Interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the Ontario Heritage Act, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as 6666 Second Line, Concession 2, East 1. Part Lot 13, (Formerly in Township of West Garafraxa), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
- The reasons for the designation are as follows: 2.

Cultural Heritage Value or Interest:

This two storey single detached dwelling was built around 1885 of squared fieldstone with a rear portion built later of rubble stone. Both parts have squared limestone quoins and hipped gable roof. Although the windows have been modernized, they retain the original segmental arches laid in stone voussoirs.

Heritage Attributes to be protected:

All exterior squared fieldstone and rubble walls including the quoins and stone voussoirs.

- 3. This By-law shall be registered against the title of the lands described as 6666 Second Line, Concession 2, East Part Lot 13, (Formerly in Township of West Garafraxa), now in Township of Centre Wellington
- 4. This By-law shall come into force and take effect upon its final passing.
