TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-076

Being a By-law to designate 499 St. George Street West in the former Town of Fergus, to be of cultural heritage value or interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property attached hereto to be of cultural heritage value or interest to the provisions of the Ontario Heritage Act, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as Fergus Plan 199, Part Lot 1, RP61R-1. 5775, Part 2 n/s St. George Street s/s Hill, Plan 77, Part Lot 8 are hereby designated to be a building of cultural heritage value or interest.
- 2. The reasons for the designation are as follows:

Cultural Heritage Value or Interest:

This 1865 single detached dwelling was built of broken course limestone with limestone quoins. The tape pointing is prominent and outlines the voussoirs over the front windows. This house features 6 over 2 windows; a central gable; a porch over the front entrance and two chimneys on both the right and left

Heritage Attributes to be Protected:

All tape-pointed exterior limestone walls. All original window proportions and pane distribution.

- This By-law shall be registered against the title of the lands described Fergus 3. Plan 199, Part Lot 1, RP61R-5775, Part 2 n/s St. George Street s/s Hill, Plan 77, Part Lot 8
- This By-law shall come into force and take effect upon its final passing.
