



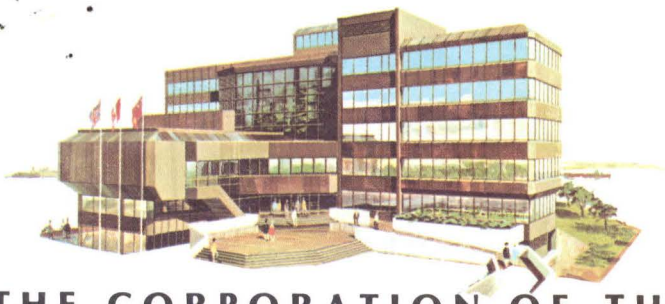

NOTICE TO THE ONTARIO HERITAGE FOUNDATION OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Sault Ste. Marie, intends to designate the property, including lands and buildings, at the following municipal addresses as properties of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, 1974, S. O. Chapter 122.

(a) 831 Queen Street East,

The Ermatinger Old Stone House dated 1814 stands as a reminder of one of the earliest settlers in Sault Ste. Marie, Charles Oakes Ermatinger, a member of a prominent Montreal family. Prior to the war of 1812, he joined the Northwest Company and settled on the north bank of the St. Mary's River near the rapids. His marriage to Charlotte Katawabeda, the daughter of the Paramount Chief of the Ojibway, assured the success of the trading post. The house he built of red sandstone, in the style popular in early Quebec, served as the center of government in the northwest part of the province, the first court house, a hotel, and a post office. Another notable point about the house is that it is the oldest remaining stone structure north of Toronto.

(b) 75 Huron Street,

The Clergue Block House stands as the second oldest building in Sault Ste. Marie, an unadorned wilderness structure used by the early fur companies. It also served as the home of a man who played an important role in the City's early days - Francis Clergue. Francis Clergue acquired the property in 1894. He rebuilt the stone wall which serves as the base and added the upper log storey to transform the powder magazine into a Block House, in which he lived for several years.
