NOTICE OF INTENTION TO DESIGNATE

TO: Corporation of the Town of Goderich 57 West Street Goderich, Ontario

Take notice that the Council of the Corporation of the Town of Goderich , on the 3rd day of October 1977, decided to designate the lands and buildings, known municipally as Town Hall as a property of architectural and/or historical significance under The Ontario Heritage Act, 1974, S.O. Chapter 122.

REASON FOR PROPOSED DESIGNATION

The present Town Hall of Goderich, situated on West Street, was formerly the Dominion Government Post and Custom's Office. Built in 1890 the building was designed by Thomas Fuller, one of Canada's leading early architects. It has an imposing and dignified presence enhanced by its set back and detachment from the neighbouring commercial blocks. The predominant building material is stone in the Romanesque style with massively gables. The rusticated stone coarsing and wall capping also adds to its monumental appearance. The building is of significant value both architecturally and historically and is most worthy of preservation and designation under the act.

Notice of objection to the designation may be served on the Town Clerk within thirty days of the 8th day of December 19 77.
