THE CORPORATION OF THE CITY OF WELLAND

BY-LAW NUMBER 10332

**A BY-LAW TO DESIGNATE THE MAIN STREET BRIDGE  
IN THE CITY OF WELLAND, OF HISTORIC OR  
ARCHITECTURAL VALUE OR INTEREST**

WHEREAS the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, authorizes the council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest;



AND WHEREAS the Council of the Corporation of the City of Welland has caused to be served upon the owner of the lands and premises municipally known as the Main Street Bridge, and upon the Ontario Heritage Foundation, Notice of Intention to so designate the aforesaid real property and has caused such Notice of Intention to be published in a newspaper, having general circulation in the municipality, once a week for each of three consecutive weeks;

AND WHEREAS no Notice of Objection to the proposed designation was served upon the Clerk of the City of Welland.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WELLAND ENACTS AS FOLLOWS:

1. That the real property, more particularly described in Schedule "A" attached hereto and forming part of this By-law, known as the Main Street Bridge located in the City of Welland, be designated as being of historic or architectural value or interest.
2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in said Schedule "A" attached hereto in the proper Land Registry Office.
3. The City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the aforesaid property and upon The Ontario Heritage Foundation and to cause notice of this By-law to be published in a newspaper having general circulation in the City of Welland.

In the City of Welland in the Regional Municipality of Niagara  
being composed of the following:

MAIN STREET BRIDGE (No. 13)

FIRSTLY:

All and singular those certain parcels or tracts of land  
and premises situate, lying and being in the City of  
Welland in the Regional Municipality of Niagara, (formerly  
the Township of Crowland and County of Welland), and  
Province of Ontario, being composed of Part of Lot 25 in  
Concession 5 in the said Township, being designated as Part 1  
on a plan of survey deposited in the Land Registry Office  
for the Registry Division of Niagara South (No. 59) as  
Plan 59R-2329.

SECONDLY:

All and singular those certain parcels or tracts of land  
and premises situate, lying and being in the City of Welland  
in the Regional Municipality of Niagara (formerly in the  
Township of Crowland and County of Welland), and Province of  
Ontario, being composed of Part of Lot 26 in Concession 5 in  
the said Township, being designated as Part 1 on a plan of  
survey deposited in the Land Registry Office for the Registry  
Division of Niagara South (No. 59) as Plan 59R-2330.
