THE CORPORATION OF THE TOWNSHIP OF SCUGOG
BY-LAW NUMBER 64-90

BEING A BY-LAW TO DESIGNATE THE HEAD CHURCH
AND CEMETERY LOCATED IN PART OF LOT 22,
CONCESSION 6, (SCUGOG ISLAND), WARD 3, AS
BEING OF HISTORIC AND ARCHITECTURAL VALUE
OR INTEREST.

WHEREAS the Council of the Corporation of the Township
of Scugog received a request from the Lake Scugog Historical
Society to designate the Head Church and Cemetery on Scugog Island
as being of Historic and Architectural value or interest;

AND WHEREAS the Council of the Corporation of the
Township of Scugog deems it desirable to designate the said site;


AND WHEREAS Council's intentions to so designate has
been duly advertised with no objections thereto;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP
OF SCUGOG Enacts As Follows:

1. That the Head Church and Cemetery located in Part of Lot 22,
Concession 6, Scugog Island, is hereby designated as being
of Historic and Architectural value or interest.
2. The purpose of the designation is as follows:

The Head Church, constructed in the late 1800's has been
under the care of the Scugog Shores Historical Museum
and the Head United Church Women's Group since 1969.
The site is to be preserved for the use and enjoyment of
of the citizens of Scugog.
3. This By-Law shall come into full force and effect on the
day of passing.

Read a First, Second and Third time and finally passed this
27th day of August, 1990.
