#### THE CORPORATION OF THE TOWNSHIP OF SCUGOG

#### **BY-LAW NUMBER 59-92**

BEING A BY-LAW TO DESIGNATE "LANDFALL FARM" LOCATED IN PART OF LOT 8, CONCESSION 5, WARD IV, MUNICIPALLY KNOWN AS 3120 HIGHWAY 7A, AS BEING OF HISTORIC AND ARCHITECTURAL VALUE OR INTEREST.

WHEREAS the Council of the Corporation of the Township of Scugog received a request to designate the "Landfall Farm" as being of Historic and Architectural Importance;

AND WHEREAS the Council of the Corporation of the Township of Scugog deems it desirable to designate the said site;

AND WHEREAS Council's intentions to so designate has been duly advertised with no objections thereto;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF SCUGOG Enacts As Follows:

- 1. That the "Landfall Farm" located in part of Lot 8, Concession 5, Ward IV, municipally known as 3120 Highway 7A, in the Township of Scugog, be hereby designated as being of Historical and Architectural Importance.
- 2. The purpose of the designation is to recognize the 125th Anniversary of the farm for historical purposes.

3. This By-Law shall come into full force and effect on the date of passing.

Read a First, Second and Third time and finally passed this 23rd day of November, 1992.
