NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the City of Windsor intends to designate the properties including lands and buildings, at the following municipal addresses, as a property of architectural and/or historical value or interest under Par IV of The Ontario Heritage Act:

PROPERTY: 204 Curry Avenue, (Lot 22 and part closed alley, Plan 245) formerly the Robert Gordon house

REASON FOR DESIGNATION:

- A typical Edwardian Frame cottage, built c.1910.
- A single-family dwelling representative of a type of house popular in Windsor in the early decade of this century.
- A front-gabled dwelling with wooden fish-scale shingles, wooden front porch with lathe-turned columns and sawn ornaments, a coloured leaded-glass transom window in the front bay window, situated on a large well-treed lot with rear garden.
- II PROPERTY: 363 Mill Street (part Lot 5, Plan 40) formerly the Sandwich Fire Hall and Stable

REASONS FOR DESIGNATION:

- The former fire hall (1921) and stable (pre 1915) are Sandwich landmarks.
- · The fire hall was designed by local architect Gilbert J. P. Jacques.
- In spite of a fire in the 1940's which destroyed the gable and hose tower belfry, enough of the fire hall remains to recall its original use.
- . The stable, while somewhat altered, is possibly the only surviving fire hall stable in the City
- The original plans, drawn by Gilbert J. P. Jacques, are available.
- The fire hall occupies a prominent site on Mill Street, one of Sandwich's important early streets.
- III PROPERTY: 351 Mill Street (part Lot 5, Plan 40) formerly the Arthur and Marie Langlois Home

REASONS FOR DESIGNATION:

- . Date of Construction c. 1888
- . Owned by the Reaume and Langlois families for 74 years.
- · Part of Sandwich streetscape for 109 years.
- Clapboard 1-1/2 storey house with gabled roof, "fishscale" shingles, ornamental bay window and side entrance porch.
- · Situated next to Mill Street Fire Hall.

Any person may, within 30 days of the publication this notice, send by registered mail or deliver to the Clerk of the City of Windsor notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Windsor shall refer the matter to the Conservation Review Board for a hearing.
