



# BY-LAW NO. 96- 147

#### To Repeal:

#### By-law No. 87-108

### Respecting:

# LAND LOCATED AT MUNICIPAL NO. 2774 KING STREET EAST

WHEREAS By-law No. 87-108, passed on the 14th day of April 1987, designated the land located at Municipal No. 2774 King Street East, more particularly described in Schedule "A" attached hereto, as property of historic and architectural value and interest, pursuant to subsection 29(3) of the <u>Ontario Heritage Act</u>, R.S.O. 1980, Chapter 337, [now R.S.O. 1990, Chapter 0.18];

AND WHEREAS City Council, in adopting Section 9 of the 14th Report of the Planning and Development Committee at its meeting held on the 24th day of September 1996, directed that-By-law No. 87-108 be repealed pursuant to Section 34 of the <u>Ontario</u> Heritage Act, R.S.O. 1990, Chapter O.18.

**NOW THEREFORE** the Council of The Corporation of the City of Hamilton enacts as follows:

1. By-law No. 87-108 is hereby repealed.

2. The City Solicitor is hereby authorized and directed to cause a copy of this by-law to be registered against the property described in Schedule "A" attached hereto, in the proper registry office.

## 3. The City Clerk is hereby authorized and directed,

- (i) to cause a copy of this by-law to be served on the owner and The Ontario Heritage Foundation by personal service or by registered mail;
- (ii) to publish a notice of this by-law once in a newspaper having general circulation in the Municipality of the City of Hamilton.
