
Re: Notice to Designate Building

We have today given official notice by registered mail to C.P.R.. Also, this form of notice will appear in the local press December 13th, December 20th and December 27th, 1978.

NOTICE OF INTENTION of the Corporation of the Town of Arnprior to designate the Canadian Pacific Railway Station, 10 John St. N., in the Town of Arnprior of architectural and historical value, under the provisions of the Ontario Heritage Act, 1974.

TAKE NOTICE that the Council of the Corporation of the Town of Arnprior intends to designate the Canadian Pacific Railway Station, 10 John St. N, lying and being in the Town of Arnprior, in the County of Renfrew and Province of Ontario, under the provisions of the Ontario Heritage Act, 1974.

The reason for the proposed designation is as follows:

This station was built in 1899 and designed by Edward Maxwell, a prominent architect of the time. This station was evidently the prototype for similar stations designed and constructed in the area by the Canadian Pacific Railway. The role of the Arnprior Station as a prototype for others in the region and the significance of its architect, give the building architectural-historical importance which would warrant its preservation. This designation will assist in preserving this attractive building which represents a period of Canada's history when railroads were the focus for economic development and vital to the movement of both people and goods.

ANY PERSON MAY, within thirty (30) days after the date of this notice, send by Registered Mail or deliver to the Clerk of the Town of Arnprior, notice of his objection, setting out the reason for the objection and all relevant facts.

WHERE NO Notice of objection is served within the thirty (30) day period the Municipal Council of the Corporation of the Town of Arnprior may pass a by-law designating this property. In the event an objection is received the Municipal Council will arrange for the proper hearing of same.

THE LAST DATE FOR FILING OBJECTIONS WILL BE JANUARY 12th, 1979.
