- Withdrawal of Notice of Intention to Designate

Please be advised that the Council of the Corporation of the City of Kitchener at its regular meeting held October 22, 2007 passed the following resolution, namely:

"That the notice of intention to designate 72 Victoria Street South under Part IV of the Ontario Heritage Act, be withdrawn, as outlined in Development and Technical Services Department report DTS-07-092; and further,

That staff be directed to initiate proceedings to list 72 Victoria Street South as a non-designated property of cultural heritage value or interest on the Municipal Heritage Register, and report back to Heritage Kitchener by January 2008."
