Subject: Owners request to repeal of designating by-law "Fairview", the Willson Page House, 40 Crawford Street, Brockville

Further to your correspondence received in our office on January 26, 2015 and the subsequent staff report presented to City Council, City Council at a meeting held on February 24, 2015, consented to your request to repeal By-Law 59-85 which designated the property known as "Fairview", the Willson Page House, 40 Crawford Street, for Historical and Architectural reasons under the *Ontario Heritage Act.*

In accordance with the *Ontario Heritage Act*, notice of Council's intention to repeal the above noted by-law will be published in the Recorder and Times Newspaper on Saturday, February 28th and Thursday, March 5th, 2015. The notice (attached) includes the description of the property and a statement that notice of an objection to the repealing by-law may be served on the clerk within thirty days of the date of publication in the newspaper. The deadline for filing an objection to a proposed repealing by-law is Monday, March 30th, 2015.

If no notice of objection is filed within the 30-day period, council shall pass a by-law repealing By-Law 59-85 at the meeting scheduled for Tuesday, April 14th, 2015. Upon repeal of By-law 59-85, you will be notified and the repealing by-law must be registered against the property in the land registry office at your cost.

If a notice of objection is served on the municipality, the matter will be referred to the Review Board for a hearing. Further details of this process will be provided if necessary.

Our office will notify you of the outcome of the appeal period after March 30th. Should you have any questions in the meanwhile, please contact us.

By-law 59-85 is available for inspection in the City Clerk's Office during regular office hours (Monday to Friday, 8:00 am to 4:00 pm).

A person may appeal the repeal of the By-law by filing a notice of appeal with the Clerk of the Corporation of the City of Brockville, not later than the **30th day of March**, **2015**. The notice of appeal must set out the reasons for the objections and all relevant facts.
