By-law No. L.S.P.-2876-86

A by-law to designate 27 Erie Avenue of historic value.

WHEREAS pursuant to The Ontario Heritage Act, R.S.O. 1980, c. 337, the Council of the municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;

AND WHEREAS notice of intention to so designate the property known as 27 Erie Avenue having been duly published and served, and no notice of objection was received to such designation;

· The Municipal Council of The Corporation of the City of London, enacts as follows:

- There is designated as being of historic value or interest the real property, more particularly described in Schedule "A" hereto, at 27 Erie Avenue, for the reasons set out in Schedule "B" hereto.
- 2. The City Clerk is authorized to cause a copy of this by law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.
- The City Clerk is authorized to cause a copy of this by-law to be 3. served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under The Ontario Heritage Act, R.S.O. 1980. 1.5
- This by-law comes into force on the day it is passed.

Historical Reasons

The house at 27 Erie Avenue (south side, west of Wharncliffe Road South), former home of Selwyn Dewdney, was built about 1914 by George A. Wenige, nine times Mayor of London.

Selwyn Dewdney, who died in 1979 at the age of 70, merits recognition as a writer, an illustrator, a geographer, a teacher and an art therapist, but especially as an expert in the field work and research of aboriginal pictography. His cataloguing of examples of rock art on sites in five provinces of Canada brought recognition among archaeologists. His encouragement of contemporary North American Indian art, particularly the work of Norval Morriseau, gave impetus to the work of other native artists. The acknowledgement of his reputation as the "Father of Rock Art Research in Canada" has been recognized by the Province of Ontario in a Memorial Plaque on the Agawa Rock Indian Pictograph Trail in Lake Superior Provincial Park.
