By-law No. L.S.P.-3191-178

A by-law to designate 26 Woodward Avenue to be of architectural value.

WHEREAS pursuant to <u>The Ontario Heritage Act</u>, R.S.O. 1990, c. 0.18, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;

AND WHEREAS notice of intention to so designate the property known as 26 Woodward Avenue has been duly published and served and no notice of objection to such designation has been received;

The Municipal Council of The Corporation of the City of London enacts as follows:

1. There is designated as being of architectural value or interest, the real property at 26 Woodward Avenue, more particularly described in Schedule "A" hereto, for the reasons set out in Schedule "B" hereto.

2. The City Clerk is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.

3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under <u>The Ontario Heritage</u> Act, R.S.O. 1990.

This by-law comes into force on the day it is passed.

Built in 1906 by local contractor H.R.K. Tozer as his private residence, 26 Woodward is a two storey, white brick house with the distinctive gambrel roof associated with the Shingle style, here enriched by an elaborate bargeboard and gable. The front facade has a full length verandah supported by columns. Stained glass windows can be found in the dining and living room windows, the round side hall window (south elevation), as well as, the transom over the front door. All of the windows and doors have brick voussoirs.
