NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Aurora intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, 1974, S. O. Chapter 122.

22 Church Street,
Aurora, Ontario.

The Church Street School, built in 1886, is recommended for designation as it is an excellent example of "Late Victorian" architectural style with elaborately patterned brickwork. It represents an example of the importance placed upon education in the 1880's and 1890's. Aurora was not a wealthy town when this school was built; nevertheless, the town employed an architect to design one of the finer public schools of the period.

Any person may, within thirty days of the first publication of this notice, send by Registered Mail or deliver to the Clerk of the Town of Aurora notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Aurora shall refer the matter to the Conservation Review Board for a hearing.
