By-law No. L.S.P.-3240-547

A by-law to designate 314 Grosvenor Street to be of architectural and historical value.

WHEREAS pursuant to the Ontario Heritage Act, R.S.O. 1990, c. 0.18, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;

AND WHEREAS notice of intention to so designate the property known as 314 Grosvenor Street has been duly published and served and no notice of objection to such designation has been received;

The Municipal Council of The Corporation of the City of London enacts as follows:

- 1. There is designated as being of architectural and historical value or interest, the real property at 314 Grosvenor Street, more particularly described in Schedule "A" hereto, for the reasons set out in Schedule "B" hereto.
- 2. The City Clerk is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.
- 3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under the Ontario Heritage Act, R.S.O. 1990.
- 4. This by-law comes into force on the day it is passed.

Historical Reasons

314 Grosvenor Street was the home of Dr. Hardy Geddes, a London physician and for whom the Hardy Geddes Home for Boys is named. His daughter Nancy Geddes Poole has been the director of the London Regional Art and Historical Museums for many years.

Architectural Reasons

Built in 1909, this two storey house Edwardian house has references to Arts and Crafts architecture of the turn of the century. The design reflects the work of British architects such as James McLaren, William Lethaby, and C.F.A. Voysey who borrowed from English vernacular tradition. The use of stucco, red brick, and rounded front bay window encompassing five windows reflect this influence. The transoms of most the windows in the house have frosted and patterned clear glass leaded windows. The house has rusticated concrete block foundation and the original roof material was wood shingles.
