By-law No. L.S.P.-3239-546

A by-law to designate 375 St. George Street to be  
of architectural and historical value.


WHEREAS pursuant to the Ontario Heritage Act, R.S.O. 1990, c. 0.18, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;


AND WHEREAS notice of intention to so designate the property known as 375 St. George Street has been duly published and served and no notice of objection to such designation has been received;

The Municipal Council of The Corporation of the City of London enacts as follows:

1. There is designated as being of architectural and historical value or interest, the real property at 375 St. George Street, more particularly described in Schedule "A" hereto, for the reasons set out in Schedule "B" hereto.
2. The City Clerk is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under the Ontario Heritage Act, R.S.O. 1990.
4. This by-law comes into force on the day it is passed.

### **Historical Reasons**

The house at 375 St. George Street was built by its first owner E. C. Hayman, President of J. Hayman and Sons General Contractors. Hayman and later his widow lived in the house until the mid-1960's.

### **Architectural Reasons**

This red brick Neo-Georgian house was built in 1930. The facade comprises three bays with a projecting frontispiece. This frontispiece is perhaps the most decorated component of the house with its columned portico with balustraded porch accessed by second floor door decorated with pilasters. The balustrade is wrought iron. The cornice is enlivened with a modillion-block treatment. There is an oculus in the broken front pediment. The entranceway comprises of a wooden front door and sidelights with multiple panes. This pattern is reflected in the second story. There are two small bay windows on the side of the house. Other features include quoins and copper eavestroughing and downspouts.
