NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Town of Orangeville intends to designate, under Part IV of the *Ontario Heritage Act* the building and lands described as West Part of Lot 2, Concession C, designated as Part 2 on Reference Plan 7R-916, municipally known as 400 County Road 23, in the Town of Orangeville, in the County of Dufferin, in the Province of Ontario.

REASONS FOR PROPOSED DESIGNATION

The house was built by George Robinson in 1871 and was retained by the Robinson family as their residence until 2012. It features a vernacular interpretation of the Ontario Cottage style. This style became popular in the 1820's and was used into the 1880's and promoted by The Canada Farmer magazine as a "cheap country dwelling house" because of its efficient floor plan, and being easy to build by settlers with limited resources.

The building is entirely clad in local red brick. The one and a half storey structure features a symmetrical façade and a centre gable over the central door. The early Georgian style popular in the area in the 1850's and 1860's is reflected in elements of this building such as the rectangular window openings topped with brick soldiering, the deep roof cornice board, the wide door casing and the relatively flat gabled roof.
