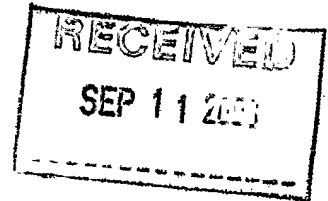

CORPORATION OF THE TOWN OF NEWMARKET

BY-LAW NUMBER 2008-50

A BY-LAW TO DESIGNATE A PROPERTY AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST.
(Hollingshead House – 449 Eagle Street)


WHEREAS Section 29 of the *Ontario Heritage Act R.S.O. 1990* authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest;

AND WHEREAS the Council of the Corporation of the Town of Newmarket has caused to be served on the owner of the lands and premises Part Lot 97, Plan 81, Newmarket; Part Block K, Plan 85, Newmarket Part 1 65R-1234, as confirmed by BA 236 as R115553; subject to NE10608 Newmarket, Regional Municipality of York, known as 449 Eagle Street, and upon the Ontario Heritage Trust, notice of intention to designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality for two consecutive weeks.

THEREFORE BE IT ENACTED by the Municipal Council of the Corporation of the Town of Newmarket as follows:

1. THAT there is designated as being of architectural and historical value or interest the real property described in Schedule "A" attached, comprising the footprint of the buildings described in Schedule "B" attached;
2. AND THAT the reasons for designation of Part Lot 97, Plan 81, Newmarket; Part Block K, Plan 85, Newmarket Part 1 65R-1234, as confirmed by BA 236 as R115553; subject to NE10608 Newmarket, Regional Municipality of York, known as 449 Eagle Street, are described in Schedule "B" hereto;
3. AND THAT the Municipal Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" hereto in the proper land registry office;
4. AND THAT the Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust and to cause notice of the passing of this By-law to be published in a newspaper having general circulation in the municipality for two consecutive weeks.

LEGAL DESCRIPTION

Part Lot 97, Plan 81, Newmarket; Part Block K, Plan 85, Newmarket Part 1 65R-1234, as confirmed by BA 236 as R115553; subject to NE10608 Newmarket, Regional Municipality of York, known as 449 Eagle Street.

SCHEDULE "B" TO BY-LAW 2008-50

REASONS FOR PROPOSED DESIGNATION

The Hollingshead House, a one and one half storey frame farmhouse, is located at 449 Eagle Street and is significant for architectural and historical reasons.

The building is an example of a unique style of construction that developed in this part of Upper Canada in the early 1800's.

Termed "Plank" construction, walls were erected by placing planks of the appropriate length and thickness, side by side, then fastening similar planking to cover where the first row butted, and then applying wooden siding to finish the exterior as in conventional frame construction. This resulted in such a sturdy structure that no conventional frame work was required to support the roof
