# NOTICE OF INTENTION TO DESIGNATE A BUILDING OF CULTURAL HERIATGE VALUE OR INTEREST

TAKE NOTICE THAT the Council of The Corporation of the Town of Aurora intends to designate the following property as a property of cultural heritage value or interest pursuant to the provisions of Section 29 of the *Ontario Heritage Act*, R.S.O. 1990, Chapter O.18, as amended. A brief statement of reasons is included.

## **Description of Property**

The George Browning House, known municipally as 15086-15088 Yonge Street, is a 2 storey residential building, located on the west side of Yonge Street south of Kennedy Street.

### Statement of Cultural Heritage Value

The George Browning House's cultural heritage value lies in its association with George Browning, a local builder; in being one of the good examples of Italianate/Tuscan villa style in Aurora; and in its significant contribution to the character of Yonge Street.

#### Historical or Associative Value

The George Browning House historical value lies in its association with George Browning, a local builder who constructed this house in 1889 as his own residence. The Brownings were a family of builders, responsible for numerous homes and other structures in Aurora and beyond.

## Design or Physical Value

The George Browning house has architectural value as Italianate/Tuscan villa style with formal balanced façade. The house is 2 storey and features yellow brick walls, low pitched/hipped roof, quoins, dormers, heavy ornamental brackets under wide eaves, and two gable-like projections in the roofline which are cut and raised above the horizontal ridge over the façade, affect Tuscan towers.

#### Contextual Value

The George Browning House has contextual value as distinguished structure on Yonge Street; it is also one of the punctuation points of one of the very few surviving stretches of dwellings on Yonge Street in Aurora.

## **Description of Heritage Attributes**

Key exterior attributes that express the heritage value of "The George Browning House", located at 15086-15088 Yonge Street, include:

- The Italianate/Tuscan villa style, 2 storey high
- Low pitched/hipped roof
- Projecting eaves supported by brackets and cornice structure
- The original window openings including the bay windows on main façade
- · The two gable-like projections in the roofline
- All exterior yellow brick and quoins

DETAILED REASONS FOR THE PROPOSED DESIGNATION CAN BE OBTAINED BY CONTACTING THE UNDERSIGNED.

Any person may, before 4:30 p.m. on the 26<sup>th</sup> day of February, 2010, send by registered mail or deliver to the Town Clerk, Notice of Objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. If a Notice of Objection is received, the Council of the Town of Aurora will refer the matter to the Conservation Review Board for a hearing and a report.
