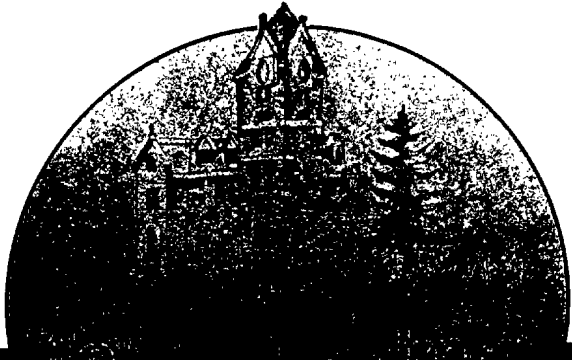

NOTICE OF PASSING OF BY-LAW NO. 3-92

TAKE NOTICE that the Council of the Corporation of the Town of Aylmer, at its meeting on January 13, 1992, enacted By-Law No. 3-92, being a By-Law to amend By-Law No. 2-86, being a By-Law to designate the property described as comprising of the West Part of Lot 12, Registered Plan 164, known municipally as 199 Talbot Street West, in the Town of Aylmer, commonly referred to as Maplehurst, as being of architectural and historical value or interest, in accordance with Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

By-Law No. 2-86 is amended as follows:

A portion of the real property at 199 Talbot Street West, more particularly described in Schedule "A" and "B", By-Law 2-86, be removed from the heritage designation as follows:

those features interior and exterior which relate to the rear portion of the building, as well as the following:

INTERIOR

- the hardwood floors patterned with intricate combinations of light and dark wood
- the unique plaster ceiling medallion

EXTERIOR

- the board and batten constructed garage to the rear of the home, containing a hay loft and horse stalls.

BY-LAW NO. 3-92

OF THE CORPORATION OF THE TOWN OF AYLMER

Being A By-Law to amend By-Law No. 2-86, being a By-Law to designate the property known municipally as 199 Talbot Street West, as being of architectural and historical value or interest.

WHEREAS

Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337, authorizes the Council of a municipality to pass by-laws, which designates real property, including all buildings thereon, to be of architectural or historic value or interest.

AND WHEREAS

the Council of the Corporation of the Town of Aylmer, has caused to be served on the owners of the lands and premises at 199 Talbot Street West, and upon the Ontario Heritage Foundation, notice of intention to amend By-Law No. 2-86, and has, pursuant to the Ontario Heritage Act, caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS

no notice of objection to the proposed amending of By-Law No. 2-86, has been served on the Clerk of the Town of Aylmer;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF AYLMER HEREBY ENACTS AS FOLLOWS:

1. That a portion of the real property at 199 Talbot Street West, more particularly described in Schedule "A" and "B", By-Law 2-86, attached thereto, and forming a part of that By-Law, be removed from the heritage designation as follows:

those features interior and exterior which relate to the rear portion of the building, as well as the following:

INTERIOR

- the hardwood floors patterned with intricate combinations of light and dark wood
- the unique plaster ceiling medallion


EXTERIOR


- the board and batten constructed garage to the rear of the home, containing a hay loft and horse stalls

2. The Municipal Solicitor is hereby authorized to cause a copy of this amending By-Law to be registered against the property described in Schedule "A", By-Law 2-86, in the Land Registry Office for the County of Elgin.

3. The Clerk is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation, to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the Town of Aylmer once for each of three consecutive weeks.


