NOTICE

TAKE NOTICE that pursuant to the provisions of the Ontario Heritage Act R.S.O. 1980, the Corporation of the Township of Collingwood intends by by-law to designate the old Alex Brown home ([REDACTED])

[REDACTED] in Ravenna as a building of historical or architectural interest. Said building being situated on part of Lot 15, Concession 9 in the Township of Collingwood in the County of Grey more particularly described as Lot 7, Plan 114, Part 2 Reference Plan 16R1447.

Believed to be the oldest home in Ravenna having been constructed as a typical pioneer log and siding 1½ story dwelling around 1850.

Since being acquired in 1901 by Mr. & Mrs. Alex Brown, [REDACTED]

The field stone kitchen was subsequently added by Alex Brown, a stone mason by trade. The interior retains the original wood floors and trim as well as several hand-hewn ceiling beams and is a home worthy of restoration, repair and preservation.

Any person who wishes to object to the proposed designation, shall within 30 days of the publication herein, serve on the Clerk of the Township, a Notice of Objection, setting out the objections and all relevant facts thereto.
