### CORPORATION OF THE TOWNSHIP OF DELHI IN THE MATTER OF ONTARIO HERITAGE ACT, R.S.O. 1980, CHAPTER 337

#### NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Township of Delhi intends to designate the following two properties including lands and buildings as properties of Architectural value under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

#### (1) BUTLER/BRINKER RESIDENCE

Being in Concession 4, Lot 22 in the former Township of Windham now in The Township of Delhi.

#### REASON FOR THE PROPOSED DESIGNATION:

The Brinker home was built in the mid-19th century by descendents of United Empire Loyalists. This is a good example of a mid-Victorian period and contains examples of several styles of architectural design. (ie. Regency, Italianate, etc.) For these reasons this building warrants designation and protection under The Ontario Heritage Act, 1980.

#### (2) VAN NORMAN/GUILER/SMALE RESIDENCE

Being Lots 5 to 10, Block 6, Plan 36B in the former Township of Charlotteville now in the Township of Delhi.

#### REASON FOR THE PROPOSED DESIGNATION:

The Van Norman House is a unique architectural remnant of the mid-19th century. It occupies a central location in the village of Normandale and together with the general sotre, the restored post office, the Union Hotel and Wesleyan Methodist Church buildings gives some indication of the size and prosperity of Normandale in the 1840's and 1850's. It also reflects sophistication and elegant taste exhibited by members of the founding village family. Because of the unusually long and dedicated ownership of the house by the Anderson/Guiler family, present day visitors to the village can appreciate this unusual and elegant house much as it was originally built. For these reasons this building warrants designation and protection under The Ontario Heritage Act, 1980.

Any person may, before the  $\frac{27\text{th}}{\text{notice}}$  day of November,  $\frac{1985}{\text{November}}$  send by registered mail or deliver to the undersigned  $\frac{1985}{\text{notice}}$  of his or her objection to the proposed designation, together with a statement for the reasons for the objection and all relevant facts. When a notice of objection has been received, the Council of the Township of Delhi will refer the matter to the Conservation Review Board for a hearing and report.
