CORPORATION OF THE TOWNSHIP OF DELHI

IN THE MATTER OF ONTARIO HERITAGE ACT, R.S.O. 1980, CHAPTER 337

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Township of Delhi intends to designate the property including lands and buildings, being Lot 1, Block 5, Plan 36B, Normandale in the former Township of Charlotteville now in the Township of Delhi, as a property of Architectural value under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

REASONS FOR THE PROPOSED DESIGNATION:

- NORMANDALE POST OFFICE BUILDING

[The Normandale Post Office was built by the Van Norman family and functioned as an important part of their enterprises until 1847. The building was the first post office in Normandale and was operated as a post office and general store until 1875. As an important part of the historic fabric of Normandale and Charlotteville Township, [REDACTED]. For these reasons this building warrants designation as a property of architectural and historical importance in the Township of Delhi and for protection under The Ontario Heritage Act, R.S.O. 1980, Chapter 337.]

Any person may before the 11th day of September, 1985 send by registered mail or deliver to the Clerk of the Township of Delhi notice of his or her objection to the proposed designation, together with a statement for the reasons for the objection and all relevant facts. When notice of objection has been received, the Council of the Township of Delhi will refer the matter to the Conservation Review Board for a hearing and report.
