NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of The Corporation of the Township of Cumberland intends to designate the properties, including lands and buildings, at the following municipal addresses as properties of architectural and historical value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

- (1) CAMERON HOUSE (known as Clendenan House) Lot 18, Concession 1, O.S. 2226 Queen Street, R.R.#1, Cumberland, Ontario - Erected prior to 1851, is one of the older surviving buildings in the area. The building, a two-storey structure of stone and articulated wood detail and wood trimmed window openings, is characteristic of this period in the Ottawa Valley. (designated as Architectural)
- (2) ANDREW WILSON HOUSE (known as Hayes House) Lot 20, Concession 4, Bearbrook, R.R.#3, Navan, Ontario - Erected prior to 1899. The building is a single residential dwelling of stone with red brick with cream coloured brick trim. (designated as Architectural)
- (3) SHAW HOUSE - Lot 10, Concession 9, 3466 Trim Road, Navan, Ontario - This residential dwelling has been in the Shaw family for 102 years and has significant Heritage interest. It was originally built as a hotel, but used only as a residential dwelling. The foundation is stone and the main building is log constructed, covered with clapboard on bottom part and aluminium siding above verandah's roof level. (designated as Architectural)
- (4) OLD WILSON HOUSE - Lot 18, Concession 1, O.S. 2800 Queen Street, Box 29, Cumberland, Ontario - Erected prior to 1861. This single residential dwelling has stone foundation, with walls of rough but uniformly squared sandstone. The double-hung windows are original Georgian mime-over-mime sashes, characteristic of period. (designated as Architectural)
- (5) CUMBERLAND TOWNSHIP (HERITAGE) MUSEUM - Lot 11, Concession 1, O.S. This museum is located 1 km. east of the Village of Cumberland on Old Highway #17 part of the original wagon route which linked Ottawa to Montreal. The Museum, which is of Heritage interest and value, was created primarily to collect, catalogue, restore and preserve artifacts, furniture, machinery and buildings used by the residents in their day-to-day lives. It reflects the surroundings of the inhabitants of the Lower Ottawa Valley during the years 1845-1945. (designated as Architectural and historical)

NOTICE OF OBJECTION to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Township of Cumberland before the 2nd day of April, 1984.
