## NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of The Corporation of the City of Ottawa on the 7th day of September, 1977, decided to designate the lands and buildings known as St. Alban the Martyr Anglican Church, 125 Daly Avenue, as a property of architectural and historical value or interest under The Ontario Heritage Act, 1974, Statutes of Ontario, 1974, Chapter 122.

SHORT STATEMENT OF REASON FOR THE PROPOSED DESIGNATION:

"St. Alban the Martyr Anglican Church, 125 Daly Avenue, consecrated in 1867, is recommended for designation as being of architectural and historical value. The oldest Anglican Church in Ottawa, St. Alban's was designed by King Arnoldi, student of Thomas Fuller. A landmark building in historic Sandy Hill, this charming English countrystyle church with Gothic detailing was the parish church for numerous prominent figures from the Confederation Era."

NOTICE OF OBJECTION to the designation may be served on the Clerk, within thirty (30) days of the 21st day of February, 1978.
