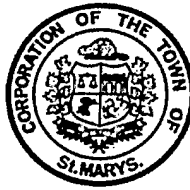

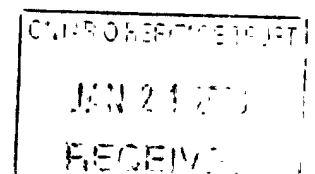

**NOTICE OF INTENTION TO DESIGNATE A PLACE  
OF ARCHITECTURAL AND HISTORICAL VALUE**

Notice is hereby given that the Council of the Separated Town of St. Marys intends to designate as a place of architectural and historical value the following property in accordance with the Ontario Heritage Act, Section 29, Part IV:

**135 Queen Street East (East Part Lot 5, North Side Queen Street)**

The two-storey stone and brick commercial building on this site was constructed in 1884 for William Andrews, Jeweller, in the Second Empire style. It is an outstanding example of the work of local architect, William Williams, and a showcase for the skills of local and area tradesmen. Unique original interior features are still in place. Its imposing storefront surmounted by the ornate clock and tower makes this building a focal point in the downtown core.

Detailed reasons for designation of this property can be seen or obtained from the office of Bruce Grant, Chief Administrative Officer, Town of St. Marys, Box 998, St. Marys, ON N4X 1B6 during normal office hours (9 a.m. to 5 p.m. Monday to Friday.)

Any person who objects to this intended designation must within 30 days of the publication of this notice serve on the CAO a notice of objection in writing, setting out the reason for the objection and all relevant facts. The Ontario Heritage Act provides that where a notice of objection has been served, the Council shall refer the matter to the Conservation Review Board for a hearing.
