

Re: DESIGNATION OF MUNICIPAL PROPERTIES IN PRESCOTT, ONTARIO.

Pursuant to Section 29(6) of the Ontario Heritage Act enclosed is a certified copy of By-Laws 23-84, 24-84 and 25-84 of the Corporation of the Town of Prescott.

CORPORATION OF THE TOWN OF PRESCOFT

BY-LAW NO. 23-84

Town of Prescott

BEING A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS THE JAMES IRWIN HOUSE, 530 DIBBLE STREET WEST AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST.

WHEREAS Section 29 of the Ontario Heritage Act, Chapter 337 R.S.O. 1980 authorizes the Council of a Municipality to enact By-Laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of the Corporation of the Town of Prescott has caused to be served on the owners of the lands and premises: known as

The James Irwin House, 530 Dibble Street West and upon the Ontario Heritage foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the Municipality once for each of three consecutive weeks;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

THEREFORE the Council of the Corporation of the Town of Prescott enacts as follows:

- There is designated as being of Architectural and Historical value or interest the real property known as the James Irwin House at 530 Dibble Street West more particularly described in Schedule A hereto.
- 2) That the Clerk is hereby authorized to cause a copy of this By-Law together with the reasons for designation to be registered against the property described in Schedule A hereto in the local Land Registry Office.
- 3) That the Clerk is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of this By-Law to be published in a newspaper having general circulation in the Town of Prescott.

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Prescott, in the County of Grenville, being composed of all Lots Thirty-Nine and Forty and part of Lot Thirty-Eight on the North side of Dibble Street and also parts of Lots Thirty-Eight, Thirty-nine, Forty and Forty-one on the southside of James Street in Block 3, according to Chipman's Compiled Plan of the said Town filed in the Registry Office for the said County of Grenville as No. 19, said parcel being more particularly described as follows:

COMMENCING at an iron bar planted on the northern limit of Dibble Street distant westerly thereon one hundred and twenty feet (120') from the intersection of said limit with the western limit of St. Lawrence Street;

THENCE northerly parallel to the western limit of St. Lawrence Street a distance of one hundred and seventy-eight and ninety-seven one hundredths feet (178.97') more or less to an iron bar planted ninety-five feet (95') southerly from the southern limit of James Street measured on a line parallel to the western limit of St. Lawrence Street;

THENCE westerly parallel to the southern limit of James Street a distance of ninety-five feet (95') southerly therefrom a distance of seventy-five feet (75') to an iron bar planted:

THENCE southerly parallel to the western limit of St. Lawrence Street a distance of twenty-seven feet (27') to an iron bar planted;

THENCE westerly parallel to the southern limit of James Street a distance of sixty-six and two one-hundredths feet (66.02') more or less to an iron bar planted on a line drawn parallel to the western limit of said Lot No. Forty-One and distant easterly thirty-five feet (35') therefrom;

THENCE southerly parallel to the western limit of said Lot No. Forty-one a distance of fifteen and seven one-hundredths feet (15.07') more or less to an iron pipe planted on the southern limit of said lot;

THENCE easterly along the southern limit of said Lot Forty-one a distance of fifteen feet (15') to an iron bar planted at the north western angle of Lot No. Forty on the north side of Dibble Street;

THENCE southerly along the western limit of said Lot No. Forty on the north side of Dibble Street a distance of one hundred and thirty-seven and seven one-hundredths feet (137.07°) to the south westerly angle of said Lot;

THENCE easterly along the northern limit of Dibble Street a distance of one hundred and twenty-five and forty-two one-hundredths feet (125.42') more or less to the point of commencement.
