## BY-LAW NUMBER 207-2007

A BY-LAW TO DESIGNATE THE LANDS AND PREMISES SITUATE WITHIN THE CITY OF WINDSOR, MUNICIPALLY KNOWN AS 534 *KILDARE ROAD* AND 536 *KILDARE ROAD*, TO BE OF CULTURAL HERITAGE VALUE OR INTEREST UNDER THE PROVISIONS OF THE ONTARIO HERITAGE ACT, R.S.O. 1990, CHAPTER 0.18, AS AMENDED

Passed the 29th day of October, 2007.

WHEREAS by virtue of the provisions of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, as amended, the Council of a municipality may, by by-law, designate a property within the municipality to be of cultural heritage value or interest.

AND WHEREAS upon consideration of the recommendation of the Windsor Heritage Committee, The Corporation of the City of Windsor deems it desirable and expedient to designate the lands municipally known as 534 Kildare Road and 536 Kildare Road, more particularly described in Schedule "A" annexed hereto and forming part of this by-law (the subject lands), to be of cultural heritage value or interest, for the reasons stated in Schedule "B" annexed hereto and forming part of this by-law.

AND WHEREAS notice of intention to so designate the subject lands, was served on the owner(s) of the said subject lands and upon the Ontario Heritage Trust and such notice was published in a newspaper having general circulation in the municipality, on Saturday, May 6, 2006.

THEREFORE the Council of The Corporation of the City of Windsor enacts as follows:

1. That the lands municipally known as 534 Kildare Road and 536 Kildare Road, more particularly described in said Schedule "A" annexed hereto, be and the same are hereby designated to be of cultural heritage value or interest, for the reasons stated in said Schedule "B" annexed hereto.

2. This by-law shall come into force and take effect after the final passing thereof on the day upon which it is electronically registered in the Land Registry Office for the County of Essex (No. 12).

#### SCHEDULE "B"

The "Quadruplex," a 2 1/2 storey red brick four-unit townhouse built in 1888, is an important and well-preserved example of the worker housing that distiller Hiram Walker was having built for his employees during the Town of Walkerville's formative years. The Picturesque Arts & Crafts style building was likely designed by the Detroit firm of Mason & Rice, as they were the architects of choice of the Walker family during this era. The most southerly units are 534 Kildare Road and 536 Kildare Road.

Early tenants were members of the Chater family, one of Walkerville's founding families. By the 1930s the units were being rented (other than to Hiram Walker & Sons employees) and in 1955 were sold.
