THE CORPORATION OF THE TOWN OF GODERICH

BY-LAW NO. 58 OF 2014

A BY-LAW TO AMEND THE WEST STREET HERITAGE CONSERVATION DISTRICT OF THE TOWN OF GODERICH

WHEREAS, pursuant to By-law 71 of 1993, the Council for the Corporation of the Town of Goderich designated the area in the Town known locally as West Street as the West Street Heritage Conservation District;

AND WHEREAS, the Heritage Conservation District Study prepared for the Town has recommended that the West Street Heritage Conservation District be expanded to include properties at 64 West Street, 44-88 West Street, 57 West Street, 43 West Street, 37-41 West Street and 33 West Street;

AND WHEREAS, the property at 37-41 West Street has asked not to be included in the West Street Heritage Conservation District;

AND WHEREAS, pursuant to Subsection 41.1(2) of the *Ontario Heritage Act*, RSO 1990, the Council of a Municipality must adopt a Heritage Conservation District Plan for each district that is designated in a By-law;

AND WHEREAS, Council considers it to be in the interests of the Town to expand the West Street Heritage Conservation District as recommended;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF GODERICH ENACTS AS FOLLOWS:

- 1. The West Street Heritage Conservation District is expanded to include 64 West Street, 44-88 West Street, 57 West Street, 43 West Street and 33 West Street as depicted in Schedule "A" attached hereto.
- 2. Schedule "A" attached hereto is adopted as part of this By-law.
- 3. The Downtown Goderich Heritage Conservation District Plan, prepared by Bray Heritage dated June, 2014 is adopted as the Heritage Conservation District Plan for the West Street Heritage Conservation District.

4. This By-law shall come into effect upon its passage.
