



### <u>DECLARATION</u> under Part V (Section 41) of the *Ontario Heritage Act*, R.S.O. 1990, <u>Chapter O. 18</u>

The notice for By-law Number 2633-14 passed by the Council of the Township of North Dumfries on the 16<sup>th</sup> day of June, 2014 was given in the manner and the form and to the persons prescribed by Regulations made by the Lieutenant Governor-in-Council under Part V (Section 41) of the Ontario Heritage Act, R.S.O. 1990, Chapter O. 18.

The 30 day appeal period expired on the 21<sup>st</sup> day of July, 2014, and to this date no notice of appeal or request for a change in the provisions of the By-law has been filed by any person in the Office of the COA/Clerk of the Township of North Dumfries.

# NOTICE OF PASSING – ONTARIO HERITAGE ACT Greenfield Heritage Conservation District Plan & Boundary

Any person may appeal the Heritage Conservation District By-law to the Ontario Municipal Board if they have participated in the public process for the adoption of the relevant Heritage Conservation District Plan under Section 41.1 of the *Ontario Heritage Act* by either making an oral submission at a public meeting or by submitting written submissions to the council of the Corporation of the Township of North Dumfries.

Any person who objects to the passing of By-law No. 2633-14 may appeal to the Ontario Municipal Board by providing the Clerk of the Township of North Dumfries with a Notice of Appeal, no later than the 21<sup>st</sup> day of July, 2014. The appeal shall set out the objection to the by-law, the reasons in support of the objection, and the required \$125 filing fee prescribed for under the Ontario Municipal Board Act; payable by cheque or money order to the "Minister of Finance". If a Notice of Appeal is received, the matter will be referred to the Ontario Municipal Board.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Municipal Board, there are reasonable grounds to add the person or public body as a party.

This Notice is deemed to be given on the 20th day of June, 2014.


