By-law No. L.S.P.- 2673-337

A by-law to designate Banting House, 442 Adelaide Street North of historic value.

WHEREAS pursuant to <u>The Optario Heritage Act</u>, 1980, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic value or interest;

AND WHEREAS notice of intention to so designate the property known as Banting House at 442 Adelaide Street North in the City of London having been duly published and served, no notice of objection was received to such designation;

BE IT THEREFORE ENACTED by the Municipal Council of The Corporation, of the City of London, as follows:

1. There is designated as being of historic value or interest the real property, more particularly described in Schedule "A" hereto, known as Banting House at 442 Adelaide Street North, in the City of London for the reasons set out in Schedule "B" hereto.

2. The City Solicitor is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.

3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under Part IV of The Ontario Heritage Act, R.S.O., 1980.

This by-law comes into force on the day it is passed.



to By-law No. L.S.P.-2673-337

ALL AND SINGULAR that certain parcel or tract of land and premises situate lying, and being in the City of London, in the County of Middlesex and Province of Ontario and being composed of part of the South Half of Lot Number Twelve in the First Concession of the Township of London (now in the City of London) which certain parcel or tract of land and premises may be more particularly described as follows, namely:

COMMENCING at a point distant 216 feet Westerly from the North West angle of Lot Number 1, Registered Plan 212, Block A, measured parallel to the South limit of Lot 12;

THENCE WESTERLY parallel with the Southerly limit of said Lot Number 12, 114 feet to the Westerly limit of said Lot 12;

THENCE SOUTHERLY along the Westerly limit of said Lot Number 12, 33 feet;

THENCE EASTERLY parallel to the Southerly limit of said Lot 12, 114 feet;

THENCE NORTHERLY parallel to the Westerly limit of said Lot Number 12, 33 feet to the Place of Commencement.
