



BY-LAW NUMBER 180-06

THE CORPORATION OF THE COUNTY OF BRANT

To designate a property in Part of Lot 34, Concession 2, geographic Township of South Dumfries, and located at 899 Keg Lane, under Part IV of the Ontario Heritage Act.

WHEREAS a request was received from the land described as Part of Lot 34, Concession 2, geographic Township of South Dumfries, to designate the site located at 899 Keg Lane under Part IV of the Ontario Heritage Act;

AND WHEREAS the Ontario Heritage Act empowers a Council of a municipality to pass by-laws to designate properties of Historical or Architectural interest under Part IV of the Ontario Heritage Act;

AND WHEREAS the Notice of Intention to Designate 899 Keg Lane was served on the owner of the property, the Ontario Heritage Trust, and was published in the Brantford Expositor as required by the Ontario Heritage Act;

AND WHEREAS the reasons for designation are attached as Schedule "A" to the by-law;

AND WHEREAS no objection to the notice for designation has been received by the Clerk of the Municipality;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF BRANT HEREBY ENACTS as follows:

- 1. **THAT** 899 Keg Lane, described as Part of Lot 34, Concession 2, as in A453366, geographic Township of South Dumfries, County of Brant, being all of PIN 32040-0015, be designated under Part IV of the Ontario Heritage Act as a property of historical and architectural significance as described in Schedule "A" attached to this by-law:
- 2. THAT the Clerk shall register a copy of this by-law, together with its Schedules against the title of the lands in the Land Registry Office for the County of Brant and shall serve a copy of the by-law together with its schedules to the owner of the land and the Ontario Heritage Trust and to publish a notice of the passing of this by-law in the Brantford Expositor.

READ a first and second time, this 22nd day of August, 2006.

READ a third time and finally passed in Council, this 22nd day of August, 2006.

BY-LAW NUMBER 180-06

Schedule A

Reasons for Designation:

Born in 1834, Charles O'Neail was the eldest son of Daniel O'Neail and Eleanor Davidson, both of whom emigrated as pioneers from Ireland and married in 1833. Daniel O'Neail was the first president of the Paris Agricultural Society and Charles was the president in 1870 and 1880. Charles married Margaret Urquhart and built this home in 1861. The family was also instrumental in having the Sacred Heart Church constructed in 1857. The house is one and a half stories with the following features; all four walls are cobblestone which were very costly to build and most cobblestone houses have only 2 or 3 sides cobblestone; Regency style with hipped roof; centre door with sidelights and transom; roughly dressed corner quoins; and, elongated cobblestone header course above the windows.
