## CORPORATION OF THE MUNICIPALITY OF PORT HOPE

## BY-LAW NO. 62/2006

Being a By-law pursuant to Section 30.1(1) of the Ontario Heritage Act, R.S.O. 1990, c.O.18, to amend Schedule A-4 of By-law No. 39/88 of the former Town of Port Hope as it pertains to the designation of 33 King Street under Part IV of the Ontario Heritage Act.

WHEREAS on April 11, 1988, Council duly enacted By-law No. 39/88, being a By-law to designate certain properties in the Municipality of Port Hope as being of historic value or interest, including property known Municipally as 33 King Street;

AND WHEREAS Schedule A-4 to By-law No. 39/88 provides a legal description of the property Municipally known as 33 King Street;

AND WHEREAS the owners of the lands described in Schedule A-4 to Bylaw No. 39/88 have requested that Council amend Schedule A-4 to Bylaw No. 39/88 to satisfy a condition of severance with respect to Committee of Adjustment file No. B 08/06;

AND WHEREAS the Municipality referred the owners' request to the Heritage Port Hope Advisory Committee as required by the Ontario Heritage Act;

AND WHEREAS the Heritage Port Hope Advisory Committee has reported to the Municipality by letter dated July 24, 2006 as requested;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF PORT HOPE ENACTS AS FOLLOWS:

- 1. That Schedule A-4 to By-law No. 39/88 be deleted in its entirety and replaced with Schedule A attached hereto and forming part of this By-law.
- 2. That a copy of the amending By-law be served on the owners of the said lands and on the Ontario Heritage Trust;
- 3. That a copy of this amending By-law be registered against the property affected in the Land Titles Division No. 39.

READ a FIRST, SECOND and THIRD time and finally passed in Open Council this  $5^{th}$  day of September, 2006.
