CORPORATION OF THE MUNICIPALITY OF PORT HOPE

BY-LAW NO. 87/2008

A By-Law to Designate Certain Properties in the Municipality of Port Hope as Being of Cultural Heritage Value or Interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990 authorizes the Council of the municipality to enact by-laws to designate property under Part IV of the Ontario Heritage Act to be of historic or architectural value or interest;

AND WHEREAS the Council of the Corporation of the Municipality of Port Hope deems it desirable to designate the building at the following municipal address:

The Richard Coffin House, 267 Ridout Street, Ward 1

and has caused to be served on the owners of the respective lands and premises, and upon the Ontario Heritage Foundation, Notice of Intention to designate the aforesaid real property and has caused such Notice of Intention to be published in a newspaper having a general circulation in the municipality, namely the "Northumberland News" and "Port Hope Evening 'Guide";

The Richard Coffin House is a two-storey residential building located on the south side of Ridout Street in Port Hope's historic neighborhood of "Englishtown".

The house is recommended for designation under Part IV of the Ontario Heritage Act as a building of cultural heritage value for architectural and historical reasons.

STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST

The Richard Coffin House was completed circa 1856 by English carpenter/builder Richard Coffin. The cultural heritage value of this midnineteenth century dwelling is evident in its fine craftsmanship. It is an excellent example of the Georgian style showcasing the unique talents of the builder who was probably also responsible for the construction of the house located at 10 Little Hope Street (on the southern portion of this lot).

The house has been sensitively and sympathetically restored recapturing the unique historic character of this heritage building.

DESCRIPTION OF HERITAGE ATTRIBUTES

Key exterior attributes that embody the heritage value of the Richard Coffin House as one of the best examples of mid-century Georgian architecture include:

Georgian houses were characterized by the handsome symmetry of their front facades. The house is symmetrical, well proportioned and rectangular in shape. The entrance doorway is a primary feature.

The entrance doorway is embellished with decorative woodwork including pilasters, a rectangular glass transom enriched with ornamental tracery, and dentil mouldings.

Most of the windows are the original double hung wooden windows with six panes over six.

The exterior is finished in a wooden ashlar finish with quoins at the corners providing a dramatic decorative contrast with the adjoining walls and additional waterproofing.
