**NOTICE OF INTENTION OF PASSING OF A BYLAW**  
**UNDER PART IV OF THE ONTARIO HERITAGE ACT**

The Council of the County of Brant hereby gives notice of intention of passing of a bylaw designating the following property under Part IV of the Ontario Heritage Act.

- The Onondaga Community Hall, located at 42 Brantford Street, Plan 102, Lots 5 & 6, Part Lot 7 N., being all of PIN number 32261-02334 and 32262-0194, County of Brant, in the geographic Township of Onondaga

**Background – Reasons for Designation**

**Architectural**

The building was designed by John Turner, a well-known Architect who created large impressive buildings throughout Southwestern Ontario. Built in Italianate style, this buff coloured brick has a bell tower and retains many of its original structural elements.

**Historical**

The Onondaga Hall has served as a focal point and the hive of activity in the Community. Built in 1874, this building served as a Council Chamber until 1976. The building served as a school for 2 years for students of S.S. #5 Onondaga Township who were waiting for the new Onondaga school to be finished.
