BY-LAW 2011-95

being a by-law to designate the lands and premises
known municipally as 29 Front Street East, Hastings,
as being of cultural value or interest


WHEREAS the Ontario Heritage Act, RSO 1990, Ch. O.18, Section 29, as amended,
authorizes the council of a municipality to enact by-laws to designate real property,
including all buildings and structures thereof, to be of cultural value or interest;

AND WHEREAS the Council of the Corporation of the Municipality of Trent Hills has
provided notice to the owner of the lands and premises known as 29 Front Street East,
Hastings and upon the Ontario Heritage Trust, intention to designate the property and
has published notice in a newspaper having general circulation within Trent Hills;

NOW THEREFORE THE COUNCIL OF THE MUNICIPALITY OF TRENT HILLS
ENACTS AS FOLLOWS:

1. That 29 Front Street East, Hastings, is designated as a property of cultural heritage
value or interest for the reasons outlined in Schedule "A" attached hereto and forming
part of this by-law.
2. That the Municipal Clerk is hereby authorized to cause a copy of this by-law together
with the reasons for designation attached hereto as Schedule "A" be registered on
title of the property described above in the proper Land Registry Office;
3. That the Clerk is hereby authorized to cause a copy of this by-law to be provided to the
owner of the aforesaid property and to the Ontario Heritage Trust and to cause notice
of the passing of this by-law to be published in a newspaper having general
circulation in the Municipality.

By-law 2011-95 be introduced and deemed to be read a first, second and third time,
passed and properly signed and sealed this 4th day of October, 2011.

DESCRIPTION OF PROPERTY

29 Front Street East, Hastings, is a commercial building on the north side of Front Street East in the Village of Hastings, now part of the Municipality of Trent Hills.

STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST

The cultural heritage value of this building lies in the existence of the front porch circa 1880. It is the last remaining porch in the business district of the Village of Hastings. The porch is comprised of wooden shingles, tongue and groove ceiling and turned posts and spindles.

It also features a six panel front door framed by inset sidelights and glazed transom. The building is constructed of red clay brick of triple wall construction in a pattern of common bond.

The cultural heritage value also lies in its association with the commercial history of the Village. Commissioned by Henry Fowlds and built by McDonnell and Bartley, it originally served as the Albion Hotel, a boarding house for lumbermen who worked along the Trent River. It later became the home and office of Richard Coughlan, Hastings' first medical doctor. It later served as a bakery, Legion hall, antique shop and artist studio. It is now used as a guest house.

DESCRIPTION OF HERITAGE ATTRIBUTES

- Random rough limestone foundation
- Red clay brick in common bond with header course
- Six panel front door with inset sidelights
- Glazed transom with three pieces of original glass and red detailing
- Porch with wooden shingles, tongue and groove ceiling and turned posts
