**THE CORPORATION OF LOYALIST TOWNSHIP**

**BY-LAW NO. 2018-006**

Being a By-law to amend By-law 410/78 and further amended by By-law 2009-104 for the purposes of including a statement explaining the property's cultural heritage value or interest and a description of the property's heritage attributes, as well as to include a legal description schedule.

**WHEREAS** By-law 410/78 was enacted by the Council of the Corporation of the Village of Bath on April 3, 1978 and amended by the Corporation of Loyalist Township on November 9, 2009;

**WHEREAS** pursuant to Section 30.1 (1) of the Ontario Heritage Act R.S.O 1990, C.O.18, as amended, the council of a municipality may, by by-law, amend a by-law designating property made under section 29 and section 29 applies with necessary modifications to an amending by-law as though it were a by-law to designate property under that section;

**WHEREAS** the amendment to include a statement of cultural heritage value or interest and a description of heritage attributes is set out in Schedule "B" to this by-law;

**WHEREAS** the amendment to include a legal description in a Schedule to the By-law is set out in Schedule "A" to this by-law;

**WHEREAS** the requirement for Council to consult with its Municipal Heritage Committee pursuant to Section 29 (2) of the Ontario Heritage Act have been fulfilled;


**WHEREAS** the Council of the Corporation of Loyalist Township has caused to be served on the owner of the property and upon the Ontario Heritage Trust, notice of intention to so amend the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality; and


**WHEREAS** no notice of objection to the proposed amendment has been served on the Clerk of the municipality;

**NOW THEREFORE** the Council of Loyalist Township enacts as follows:

- 1) That By-law 410/78 as amended by By-law 2009-104 be further amended by adding the following Schedule "A" of this By-law to By-law 410/78 as Schedule "A".
- 2) That By-law 410/78 as amended by By-law 2009-104 be further amended by adding the following Schedule "B" of this By-law to By-law 410/78 as Schedule "B".
- 3) The municipal solicitor is hereby authorized to cause a copy of this amending by-law to be registered against the property described as PT LT 11 CON 1 ERNESTOWN; PT RDAL BTN LOTS 10 & 11 CON 1 ERNESTOWN CLOSED BY LA198051 PT 1 29R9597; S/T LA285335; LOYALIST TOWNSHIP in the proper land registry office.
- 4) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust and to cause notice of the passing of this by-law to be published in the same newspapers having general circulation in the municipality.

## **SCHEDULE 'B' TO BY-LAW 2018-006**

### **Description of Property-212 Church Street, Bath**

212 Church Street, Bath is a rectangular building that has a main block with a gabled façade to the west. There is a bell tower located at the front center of the building. Located on the east side of Church Street, it is one of the first buildings seen when entering the Village of Bath from the north on County Road 7.

### **Statement of Cultural Heritage Value or Interest**

212 Church Street, Bath has architectural value in both the exterior and the interior of the church. The exterior is a tribute to the form of the Parish's second church, built between 1793 and 1795 and lost to fire in 1925. The interior of the worship area retains decorative treatment of the era of the December 1925 opening of the new church building.

Historical and associative values in the community rest on its long-established role for an associated parish, first organized in 1787. The building was seen as a spiritual home for community members. The present St John's sits on the site of one of the first Anglican Churches in Upper Canada, built in 1787. The church's first minister was Reverend John Langhom who was appointed missionary to Ernestown and Fredericksburgh townships in 1787. He was also the first resident Anglican clergyman in the Bay of Quinte region and the second in what is now Ontario.

212 Church Street has contextual value supporting the character of the area of residences, social life, and education, established north of the commercial main street and waterfront with wharves and manufactures.

### **Description of Heritage Attributes**

#### **Exterior**

- Scale and massing
- 15 Stained glass windows with gothic style arch surrounds
- Bell tower with four pinnacles
- White stucco exterior
- Buttresses
- Limestone corner stone with dates of the first and of the present building
- Louvered belfry window on front tower
- Plaque with church name and 3 dates on front of bell tower
- Gothic style door with stain glass
- Cemetery and grounds
- Ontario Heritage Trust Plaque (free standing)

#### **Interior**

- Painted decoration (replica of original 1925 colourings, done in 2009)
- Treatment of ceiling beams
- Hanging lights
